April 24: The MSE CIT met to continue work on the Comprehensive Needs Assessment (CNA) and Title I Plan for the 2023-2024 school year. To date this team has facilitated the creating and administering perception surveys for staff, students, and parents/guardians as well as the staff demographic survey, and School Systems Review. This data is in the process of being analyzed and will be used to complete the CNA and Title I Plan.

April 24 & 25: The elementary school hosted a Scholastic BOGO Book Fair. This event was made possible through the work of Marla Estes and the PTO members and other volunteers that staffed the event. Many students were able to shop for on sale reading material.

April 25 & 26: The elementary staff participated in the Food Service Administrative Review. Since breakfast is served in the classroom, each of those locations counts as a point of sale/service and is subject to review. The overall program review was very positive. A huge shout out to the elementary teachers, parapros, food service staff and to Cindy Sutherland for the successful completion of this process.

May 3: I participated, virtually, in the fourth and final session of the MAS/FPS Title I Principals training. These sessions provided a rich knowledge of the Title I Processes, Procedures, Requirements, as well as best practices for creating and supporting programming at the elementary school. The information from these sessions is already being used to guide the work of the MSE CIT and to identify areas for improvement for next year.

May 5: Elementary staff participated in professional learning regarding the LEGO Briq Essentials and LEGO Spark Essentials kits. These kits will allow students and teachers to address much needed STEM/STEAM skills and are designed to also support cooperative learning, problem solving, and communication skills.

May 12: Elementary students will participate in the Fund Run. This is the PTO's biggest fundraiser and the funds are used to provide classroom supply grants to teachers and paraprofessionals, fund student field trip opportunities, and much more.

Other Items of Interest:

Construction: The building of the two new classrooms on the northeast side of the building is in its early stages. Crews began working on a temporary road and site work on May 10th. The crews have also begun removing the concrete pad at the base of the northeast stairs and will soon begin to remove the stairs themselves once a temporary wall is in place. As you might imagine many students are thrilled to see and hear the heavy equipment. Teachers may not be as thrilled.

M-STEP: All scheduled test sessions have been completed. In the upcoming days we will be working to complete make-up sessions. In past years, we have attained a 100% tested participation rate. Unfortunately, this may change this year due to the sudden withdrawal of some fifth grade students.

Fastbridge (Benchmark) Assessment: Elementary students will complete Fastbridge Assessments in the area of reading and mathematics during the week of May 15th. These assessments are required by MDE and legislation but also serve as an indicator of student growth over the year.

Curriculum Committee:

The team participated in TRAILS Tier 1 Training on April 17th and discussed with MS/HS principals and social workers implementation process. B4 Discipline - MDE reminds schools that when a special education student's behavior results in disciplinary removal, IEP Teams should consider and implement appropriate behavioral supports. Failure to do so may deny the student a free appropriate public education (FAPE) and violate the IDEA. MOISD is working with the special education department to provide insight and support into ensuring discipline procedures are being followed according to state and federal guidelines in the following areas: patterns of behavior, in-school and out-of-school suspension, manifestation determination review and interim alternative educational setting.

MiPSE - MOISD continues to plan steps to ensure training of special education staff in their local districts. Teacher training will begin in August to enable staff to navigate and use the program.
