Workshop Discussion:

M46 Bus Stop - A concern about how to perform a bus stop on M46 was brought to the Transportation Director. There are two ways that the stop could be performed: a Hazard Light stop vs. an Eight Light System. Board action would be required to change the current way the stop is done.

Bond Invoice – Three invoices were submitted, one from Christman for series I and series II and two invoices from Mathison Mathison for Series II.

Community Center Lease - The Center has requested a 20 year lease in order to apply for a grant.
