Flag discussion – Mr. Cole started a conversation with board members that stemmed from parent communications that he has recently had. A parent raised a concern about students being allowed to display certain flags in support of their beliefs and other students being denied the opportunity to support theirs. Mr. Cole asked the board to consider a policy that would only allow for the American Flag and the Michigan Flag as the only flags displayed on campus. Clubs are allowed on campus for students (with permission/supervision) to meet for fellowship.
